#### DHHS - Emergency Rental Assistance

- Limited to \$3,000 max to pay to cancel an eviction
- Household income must be below 30% AMI

#### Just Cause / Good Cause eviction protection

- Sponsor: Del. Jeanelle Wilkins District 20 (White Oak and Silver Spring)
- Enable local jurisdictions to implement good cause protections
- Require a landlord to provide a good reason for eviction, failure to renew a lease, or termination of a holdover tenancy
- Passed by full House of Delegates 96-37 in 2024 session
- Died on Sine Die without a vote from Senate Judicial Proceedings Committee

# **Tenant Safety Act**

- Sponsor: Del. Vaughn Stewart District 19 (Aspen Hill and Derwood)
- Protects tenants from living in substandard housing without tangible recourse
- Allows multiple tenants to join a single rent escrow case who are experiencing the same issues
- Allows tenants to recover attorneys fees and costs
- Protect tenants with warranty of habitability (don't have to pay full rent amount when landlords refuse to make repairs)
- Passed in both houses and signed by Governor Moore went into effect Oct 1, 2024
