Jim - For sidewalk repair will we be reimbursed by DOT? Crystal – no, the urban district gets a tax and they are expected to fund, support, and maintain the urban district within the space that's in their zone of control

Sidney – signage, banner program, printing the actual banners, we still have some things we didn't get from the construction, the number of events that they're hosting with that funding is 2 per year, they're hoping for CUPF to allow for greater funding capability to do events

Question on competitiveness salary wise for attracting workers for the new county positions

Arts & Entertainment District Panel

Stuart Eisenberg, Executive Director – Hyattsville Community Development Corp.

Involved in lone PG county A&E district, Gateway arts, they are the party standing, function is to principally report, ensure resources are known to be accessible, interact at a ground level to ensure arts and entertainment are happening, put resources and people in front of people and get out of the way, their job is information brokering, and they also have their own projects. As the manager they keep decision makers informed. Org has a budget of \$400-550k and they get infusions of \$300k for passthroughs, and they're hoping for a passthrough of \$1.5m to come in. Money isn't what they do, facilitation is, much prefer the private sector to spend their resources than the puny gov resources. The arts are transformative, and if you're not tapping into that at the most fundamental level then you won't be having the social change, economic change, change for people to empower themselves that you could otherwise.

Elizabeth Gallauresi, Arts Administration, Event Planning, and Cultural Programming – The Modern Muse

The WUD is a government model; Bethesda UP is the designated management structure, at times other entities want to switch over and you can only do that when redesignation comes up For Wheaton, we started off strong in 2006, in 2016 was a struggle, the cultural arts center came out of that struggle;

A&E district is responsible for being able to identify specific goals we want to take place, tie funding for it, make sure there's staffing to accomplish those things.

David Mitchell – It sounds like people are coaching artists and that’s something to be cautious of, as not treating artists as just givers, but they’re also receivers, businesses, entities within the arts district, how do we empower artists? How do we empower them so they have a better understanding of the ecosystem?

Steven Skerritt – Wheaton has so much going for it, you have all of the pieces, you have the energy, it’s harnessing that energy for something that works for you, the artists, and the community.
