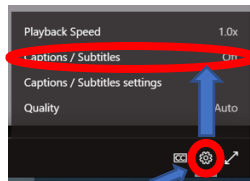
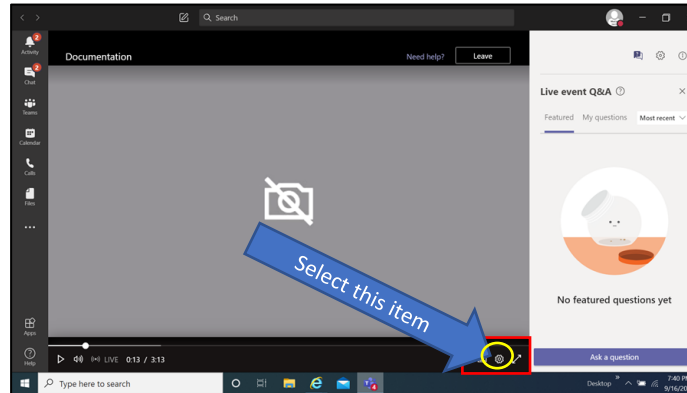


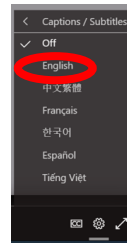

Who is OGM?

In coordination with the Office of Procurement, Office of Management and Budget, and Department of Finance, OGM develops countywide policies and procedures regarding grants management that are consistent with the County's racial equity and social justice goals.

OGM has two areas of focus:

Incoming Grants

We empower Montgomery County Government's executive branch by leveraging federal, State, and private grants.

Strategically using grants to supplement County tax dollars, enables the expansion of both new and existing programs and service. This enhances the County's ability to serve its residents more effectively and efficiently without raising taxes.

Outgoing Grants

We foster positive community impact through the administration of competitive grants programs and issuing grant agreements that align with County priorities and enrich the lives of County residents.

The Outgoing Grants team prioritizes the success of grant applicants and awardees by delivering guidance, applicant training resources, and thorough information on compliance requirements. Together, we strive to empower initiatives that drive meaningful change and enhance the well-being of our community.

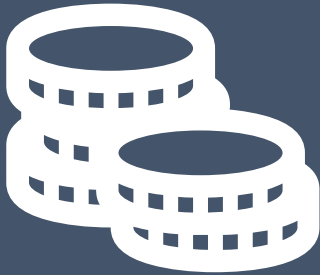

FY26 County Executive Recommended Budget



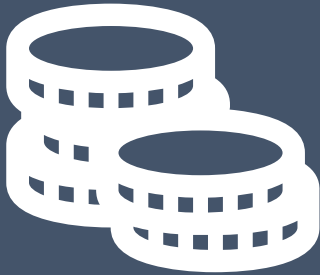

FY26 CE Rec Budget: OGM Portion



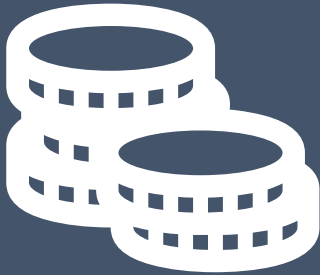
- **OGM budget starts on page 34-1** of the [FY26 CE Rec Budget Book](#)
- **Maintains current staff levels within OGM** making adjustment for inflation and other increased operating costs
- **Adds a Grants Focused Attorney** in the Office of the County Attorney (page 28-1) to support both Incoming and Outgoing Grants
- **All OGM changes related to Incoming Grants** (grants the County applies for)
- **Cuts \$17,000** for a Grants Training Conference for County Staff since we will only hold every few years
- **Adds \$100,000** for County Grant Data Tracking and Approval System

FY26 CE Rec Budget: Community Grants NDA Portion (1 of 2)



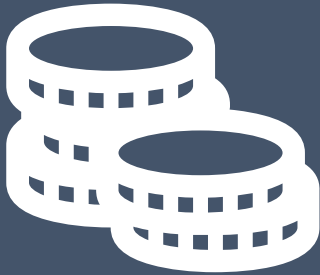
- **Community Grants Non-Departmental Account (NDA)** is a special pool of funds not within a single department
- **Community Grants NDA budget starts on page 73-4** of the [FY26 CE Rec Budget Book](#)
- In the FY25 CE Recommended Budget, the **Community Grants NDA was only 6.6%** of the total estimated County nonprofit funding
- **Adding the Cost Sharing Capital Grants only brings this estimated total up to 8.1%**
- For FY25 OGM projects that **the Community Grants NDA will be only 20%** of competitive nonprofit grant programs with **68% from department base budgets**
- **Take Away: the Community Grants NDA is a literal fraction of total nonprofit opportunities** for both grants and contracts

- **Continues multi-year awards for Community Grants and Underserved Communities Projects (UCP) grant program winners** at current levels plus 3% inflationary increase
- **Continues Legacy Renewals through FY26** at current levels plus 3% inflationary increase
- **All Community Grants, UCP, and Legacy Renewals will be reviewed** for performance and may be cut if not in compliance or performing
- **Maintains \$1M for Nonprofit Incubators**
- **\$1M for Nonprofit Technical Assistance**
- **\$3M for Cost Sharing Capital Grants** focused on matching State Awards (\$2M for Non-Arts and \$1M for Arts capital projects)

- **FY25 Place-Based Management Grants Program:**
Applications still being evaluated and scored.
- **FY25 Food As Medicine Grants Program:** Review complete and recommended awards sent to CAO. Awaiting final approval.
- **FY25 Cost Sharing Capital Grants Program:**
Administrative Review stage complete. Eligible applications moving on to reviewers for evaluation and scoring.

Currently Open FY25 Grant Programs

- **FY25 Nutrition Benefits Outreach Grant Program:** *(Opened March 25, 2025 and closes Wednesday April 23, 2025 at 11:59 PM):* The FY25 NBO Grant Program (formerly SNAP Outreach Grant Program) will solicit grant applications for qualified state-designated community-based organizations (CBOs) to conduct Supplemental Nutrition Assistance Program (SNAP) outreach, application, and enrollment assistance to Montgomery County families with children. These programs reach Montgomery County families that are eligible, but not yet enrolled in SNAP. OFSR expects to award \$300,000 in grant funds.

April FY25 Grant Programs – First Half of Month

- **FY25 Fentanyl Use, Overdose, and Death Reduction (FUODR) Grant Program:** *(Anticipated Launch: 2nd Week of April 2025)* The Department of Health and Human Services has allocated \$100,000 of Opioid Abatement Funds for a grants program that aims to reduce the number of persons using, overdosing and dying from the use of fentanyl in Montgomery County, MD. HHS anticipates making 1-2 awards with a \$50,000 minimum and \$100,000 maximum.
- **FY25 Community Projects Fund Administration Grant Program:** *(Anticipated Launch: 2nd Week of April, 2025)* The goal of this grant program is to compete out to a nonprofit provider the administration of the Community Project Fund pool of resources. The award winner will also be responsible for providing coaching, mentoring, and sustained technical assistance to small, emerging, and volunteer led nonprofit applicants and award winners for this pool of resources. \$1.2 million is available for this grant program and OGM anticipates making a single award to one partner.
- **FY25 Nonprofit Incubators Grants Program:** *(Anticipated Launch: 2nd Week of April 2025).* The goal of this grant program is to compete out funds to nonprofit providers for the administration of Nonprofit Incubators serving nonprofits throughout the County. OGM seeks innovative proposals that explore administrative shared serves, micro-grants administrative needs, common workspaces, as well as sustained coaching, mentoring, and community building for incubator participants. \$1 million is available for this grant program with OGM anticipating 2-3 multi-year awards ranging from \$300,000 to \$500,000 per year.

April FY25 Grant Programs – 2nd Half of Month

- **FY26 Cost Sharing Capital Grants Program:** *(Will open mid-April, 2025 after the State finishes its budget process).* OGM will soliciting grant applications from qualified 501(c)(3) nonprofit organizations seeking to implement capital projects that help provide access to resources, direct services, historical preservation, cultural enrichment, and/or other benefits to Montgomery County residents. The FY26 competition will be limited only to projects that have an existing State capital award for the same project. The FY26 CSCG competition will be multi-stage with a short initial application to assess need and eligibility with a longer second stage.
- **FY25 Community Youth Mental Health and Substance Use Initiatives Grants Program:** *(Anticipated Launch: Late April 2025).* The department of Health and Human Services will solicit grant applications Award up to \$1.3 million in Juul and Altria settlement funds to support youth programming initiatives focused on vaping cessation, mental health, and substance use prevention. HHS anticipates up to three awards ranging from \$250,000 to \$500,000 each.

May Upcoming FY25 Grant Programs

- **FY25 Nonprofit Technical Assistance and Management Support Grants Program:** *(Anticipated Launch: Early April 2025).* The goal of this grant program is to compete out funds to nonprofit providers for the administration of Nonprofit Incubators serving nonprofits throughout the County. OGM will seek innovative proposals that help prepare County nonprofits to independently and successfully apply for win, implement, and comply with County, other local jurisdiction, private, State, and federal awards. This award may include a sub-granting component. \$2 million is available for this grant program with OGM anticipating 4-5 multi-year awards ranging from \$300,000 to \$500,000 per year. Portions of this funding pool may be integrated into the FY25 Nonprofit Incubator and FY24 Community Projects Fund Administration Grant Programs.
- **FY26 Renewals:** At latest, OGM will open modules to collect information/proposal for all multi-year awards for their FY26 funding. These grant programs include, but are not limited to, Community Grants, Legacy Renewals, and FY25 Cost Sharing Capital Grants, and other department led multi-year grant programs. Program continuation and/or final award amounts will depend on County Council actions during their budget deliberations.

To be Scheduled FY25 Grant Programs

- **FY25 Emerging Business District Grant Program:** The Community Engagement Cluster (CEC) is soliciting grant applications under the County's FY 2024 Emerging Business Districts Grants Program, which aims to establish Business Improvement Districts or Urban District Corporations within Montgomery County by subsidizing the formation and support of non-profit commercial district management entities to conduct place making, place management, branding, and economic development activities in a designated neighborhood.
- **FY25 Community Reinvestment and Repair Fund Grant Program:** Bill 4-24 "Community Reinvestment and Repair Fund Commission – Established," allows a portion of cannabis tax revenue to be directed to Montgomery County communities most harmed by the so-called War On Drugs. Through this grant program the County will support community-based initiatives intended to benefit low-income communities and that serve disproportionately impacted areas of the County. Total awards are estimated at \$1 million for FY25.
- At least three other potential department grant programs currently under discussion.

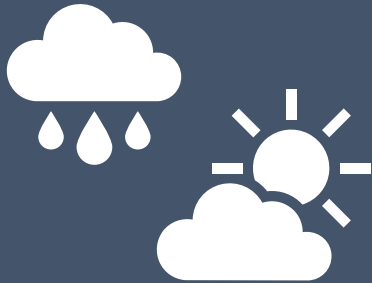

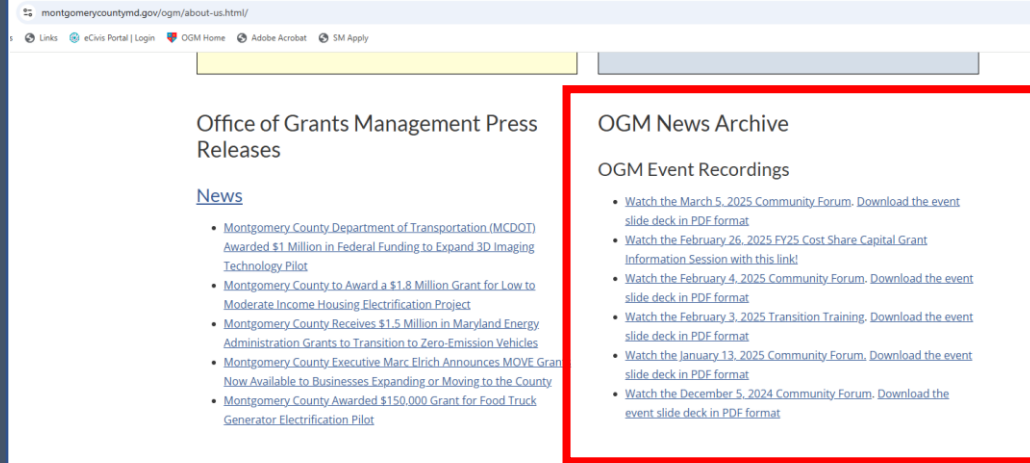

Step 2: Get Compliant



- Check Out OGM's **5 Steps To Prepare For Montgomery County Grants** as an [html](#) or [pdf](#).
- [Register and Maintain Good Standing with the Maryland State Department of Assessment and Taxation](#) - Ensure your organization is registered and in Good Standing with the Maryland Department of Assessment and Taxation (SDAT). This status is required to receive grants and payments.
- [Register with CVRS](#) - To receive grant payments, your organization must be registered in Montgomery County's Vendor Registration System (CVRS). Keep your registration current and sign up for ACH to get funds faster.

Step 3: Create a Profile in Euna

Step 4: Check Out Individual Grant Program Solicitations



1. **Check out the various Solicitation Tabs for a specific grant program.** OGM elevates all key information to these tabs so that you can assess whether the grant program is a good fit for your organization. If not, move on to other opportunities.
2. **If the Grant Program looks like it is a good fit, download and read the whole Notice of Funding Opportunity (NOFO).** The devil may be in the details so understanding the full NOFO will help you make an informed decision of whether to apply or not.
3. **Make a “Go/No Go” Decision with your Team.** Discuss with your team on whether a) you are really competitive for the opportunity (not just eligible), b) roles and responsibilities for the application, and c) other competing priorities. Decide whether to commit to an application or let the opportunity pass.

Step 5: Apply Common Application Elements



- **Application Title** – Name of organization and proposal title
- **Lead Applicant Information** – Contact Information for Applicant that will be used in any resulting Grant Agreements
- **Lead Applicant Background** – Organization size and leadership demographics (optional and NEVER used as part of the evaluation and scoring process)
- **Memorandum of Understanding** – If the application represents a cooperative effort between more than one organization then the County requires an MOU outlining the relationship, roles, and responsibilities of all parties.

Step 5: Apply Standard Application Elements



Standard Tasks – Scaled Up or Down Based on Award Size

- **Project Strategy/Scope of Work** – Narrative description of project being proposed and impact
- **Budget** – Detailed itemization of costs for the proposal
- **Budget Narrative** – Narrative description of these costs and why they are necessary for the project
- **Timeline/Implementation Plan** – Description of how the project will be implemented over the grant term
- **Performance Plan/Goals** – Outline of outcomes and outputs associated with the project quantitative and qualitative metrics to be collected, methods for collecting, and targets as well as any other evaluation methods.

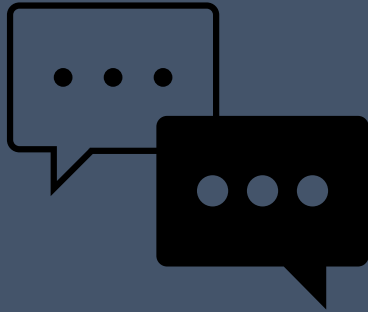
Step 5: Apply Potential Application Elements



Less Common Tasks – Added for Large Awards or More Complex Grant Programs

- **Staffing Plan** – Narrative description of all positions associated with the project, % of time dedicated to project, salary/stipend level for position, and why the position is needed for project success
- **Performance History** – Description of outcomes achieved by applicant that demonstrate their success in a similar project to the proposal
- **Outreach Plan** – Description of the applicant's strategy to reach the target population
- **Grant Program Specific Tasks** – Different grant programs addressing unique sectors may have additional Tasks specific to that sector, initiative, and/or Target population
