- Racial Equity Impact Assessment (REIA) Supplemental Appropriation (SA) #24-32 Re: State's Attorney's Office - US Department of Justice, Office of Justice Programs, Bureau of Justice Assistance (BJA) Grant FY23 Body-worn Camera Policy and Implementation Program to Support Law Enforcement Agencies - Competitive Grant Award (\$948,103)
- I. FINDING: The Office of Racial Equity and Social Justice (ORESJ) finds that Supplemental Appropriations #24-32 FY23 Body-worn Camera Policy and Implementation Program to Support Law Enforcement Agencies – Competitive Grant Award is inconclusive. While the funding will increase digital evidence processing capacity for the State Attorney's Office (SAO), ORESJ is unable to draw conclusions about the supplemental appropriation's ability to advance racial equity and social justice in the County.
- II. **BACKGROUND:** The State's Attorney's Office was awarded a Bureau of Justice Assistance Grant to enhance digital evidence processing capabilities. SA #24-32 FY23 Body-worn Camera Policy and Implementation Program to Support Law Enforcement Agencies - Competitive Grant Award will accelerate and enhance digital evidence production, processing, and data interpretation, increasing prosecutorial, defense, and judicial confidence in the lawful disclosure of digital evidence. The program will promote improvements in the effective use of digital evidence, prosecutorial decision-making, and case outcomes. These funds will provide resources needed to address the increase in the availability of body-worn cameras (BWC) and other digital evidentiary data. Funding will be used to create four grant-funded, three-year term Digital Evidence Technician positions.
