Re: Racial Equity Impact Assessment (REIA) Supplemental Appropriation (SA) #25-74

FY25 Department of Corrections and Rehabilitation, General Personnel and

Operating Costs (\$6,210,166)

- I. <u>FINDING</u>: The Office of Racial Equity and Social Justice (ORESJ) finds that Supplemental Appropriation #25-74, FY25 Department of Correction and Rehabilitation, General Personnel and Operating, neither advances nor impedes racial equity and social justice in the County as the increased funds would cover personnel and operating expenditure overages. The supplemental funds would enable the department to maintain current operations and meet obligations to care for those who are incarcerated.
- II. <u>BACKGROUND</u>: The purpose of SA #25-74 is to provide additional resources to fund personnel and operating expenses through the end of the year. Actual expenses are expected to exceed the FY25 DOCR budget. More specifically, personnel cost overages are attributed to higher than budgeted overtime expenses from mandatory holdover caused by ongoing vacancies. Operating expense overages are primarily related to increases for food and medical services, the purchase of security-related equipment to eliminate contraband entering facilities, and nursing and psychological contracts for the care of incarcerated individuals. These increases are related to increases in the incarcerated population across DOCR facilities.

- III. <u>ANALYSIS</u>: ORESJ has previously reviewed supplemental funding related to general personnel and operating costs for DOCR in SA 24-87.
