- Board voted (6 Yes, 0 No) to approve the 8/18 Agenda and Minutes
- 3. Committee Reports:

### **Summary:**

 Board reviewed the July 2022 report of all public complaints of police misconduct received either through the <u>PAB Complaint Portal</u> or received by local law enforcement agencies

#### **Actions:**

- Board voted (8 Yes, 0 No) to approve the July 2022 Report data and requested staff to post the Report on their internal SharePoint to review format and provide any comments for August 2022 report
- 4. Unfinished Business:

### **Summary:**

- Board reviewed a draft of policy points around MPTSC's proposed emergency regulations and whether the PAB should take a policy position, opposing or having concern with the following points:
  - The MPTSC's proposed regulations at .03D(1)(b) and .04D(1)(b) would permit local jurisdictions to limit membership on PABs and ACCs to "legal residents or citizens of the United States."
  - Under the proposed regulations at .04D(1)(d), any local jurisdiction could limit its ACC members to persons of "good moral character." "Good moral character" is defined under the proposed regulations at .02B(7) as meaning "an individual

- behavior, habits, and actions may generally be regarded as being: (a) Honest, ethical, candid, trustworthy, diligent, and fair; (b) Respectful of the law and committed to the administration of justice; and (c) Observant of the rights of other individuals."
- o In addition, at .04D(2) of the proposed regulations, local jurisdictions would be permitted to exclude an individual from appointment because either the individual "is under criminal investigation by a law enforcement agency," "charged with a crime pending before a court," or "has been convicted of, or has receive probation before judgement for a felony or misdemeanor for which a sentence for one or more years could have been imposed."

Wheaton Library was also suggested as a future location for a meeting

### **Summary: Public Awareness**

- Board reviewed the public awareness options presented by PAB Staff (The Board had
  previously requested PAB staff to make their meetings and actions more prominently
  displayed for county residents, in an effort to get more public participation and
  feedback regarding their work and how it affects everyone).
- Options included but were not limited to highlighting the PAB biweekly meetings in the Regional Service Center weekly newsletters and joining future Regional Citizens Advisory Board meetings. Social media posts and electric signs around the county were also suggested
