Subject #1 started a group chat to which Subjects #2 and #3 replied with racial slurs. The victim took a picture of the messages on his phone and showed them to school administration. The school will handle the consequences.
1/25/2024	4D	Other	Race		Anti-Black		Individual(s)	A middle school staff member found a drawing in a classroom that was directed toward a specific student (victim). The drawing was supposed to be a representation of the victim and depicted derogatory racial sterotypes. When questioned by the counselor, the victim stated things were going well in school and made no mention of bullying or other issues. The victim was not notified of the drawing so further trauma would not be caused.

An unknown subject had taken pictures from the victim's account and modified them in an antisemitic manner. The messages were reported to the social media platform and were removed.
