The community center has CCTV footage but it did not capture the assault, however, the CCTV footage captured 3 juveniles chasing after the victim.

When questioned, the subject stated the victim had called him a derogatory homophobic term and in retaliation "pantsed" the victim. Witnesses confirmed that no part of the victim's body was exposed. Officers concluded this was a 4th degree sexual offense. No charges were filed at this time. The school will handle the matter administratively.
