After the subject specifically mentioned that the victim is Jewish, multiple participants began mocking the victim and the Jewish religion. There were over fifteen direct messages that would be considered biased speech directed at the victim. The victim stated that the subject attended the same school as him.

The victim and subject exchanged words and the teacher intervened. During this intervention, Subject #2 gave what appeared to be a Nazi salute. Subject #2 stated the gesture was not meant as a Nazi salute, the subject was imitating the Elon Musk salute. The school will handle the incident administratively.
