No injuries to the victims were observed. Officers recovered 4-5 shell casings in the roadway.

When the victim told the subject to watch his mouth, the subject then put his vehicle in reverse and tried to hit the female victim's leg while she was standing on the curb. When a witness tried to step in, the subject left the area in his vehicle. The complainant stated the subject had been harassing her visitors and kids for over 3 years. The complainant wished to file a peace order against the subject.

The subject was then removed from the group chat. The victim identifies as They/Them and was made aware of the comment by his friends. The incident did not occur during school hours or using school technology. The 3 students are all friends.
