The subject also provided a statement that did not include racial slurs and had a different account of events. There were no witnesses to the reported events.

The victim's mother emailed a copy of the poem to the officer as well as the school and also some new organizations in area.

School staff conducted a search of the victim and subject, due to the comment about the knife. The subject had multiple CDS/marijuana items in his possession. The school will handle the incident administratively.
