MCP 611 ONLINE COLLISION REPORTING SYSTEM FEATURES:

- A picture or document attachment tool
- Automatic document routing that allows for supervisor comments and officer comments prior to the Traffic Operations Division review and the Command review.
- Email notifications and reminders to all parties involved
- Search and digital repository system for all reports
- Automatic distribution to the Seven Locks Garage, Risk Management, and the Collision Review Committee

PROCEDURES

The online report will be forwarded in the following manner:

1. Report created by supervisor, photographs attached, ACRS completed, and supervisor's determination of fault and preventable circumstance. The supervisor may enter comments and submit.
2. The submitted report generates an email that alerts the involved officer to review and comment, if desired. The officer then submits.
3. The submitted report generates an email to the Traffic Operations Division Sergeants who will review the ACRS and the supervisor's MCP 611 determinations. The MCP 611 can be rejected with comments back to the supervisor, who receives an email about the rejection, or it can be accepted. If

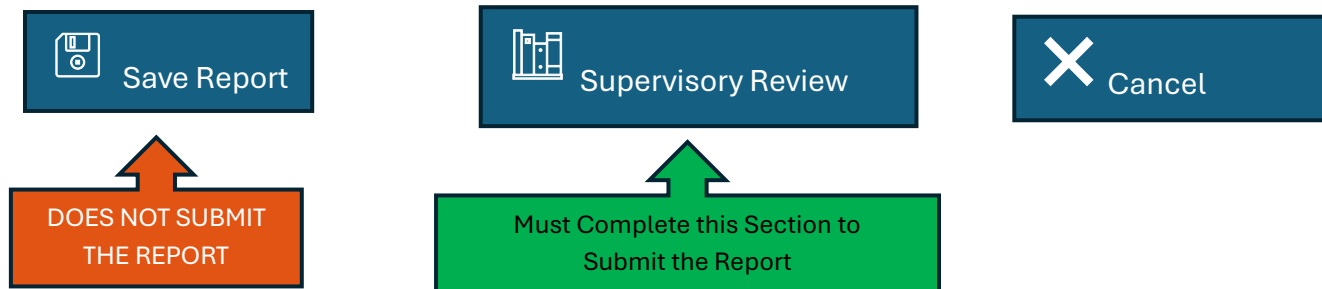
the traffic sergeant rejects the MCP 611 based on errors in the ACRS report, the traffic sergeant shall ensure that the ACRS report is reopened before rejecting the 611.

4. The accepted report will generate an email to the involved officer's chain of command stating that it is available for their review. At this point, the report can be accepted or rejected with comments. A rejected report will generate an email to the officer's supervisor.
5. The accepted report will be automatically forwarded to the [MCPVehicleDamage](#) Active Directory group, which includes Seven Locks Garage, Risk Management, and the Collision Review Committee.

INITIAL REPORT INSTRUCTIONS:

The initial report should be started in the manner described below to maintain a chain of command review process. Following this process helps to make sure that no collision is reviewed by the same individual twice.

Assistant Chief	Assistant Chief of another Bureau or Captain of Traffic Operations

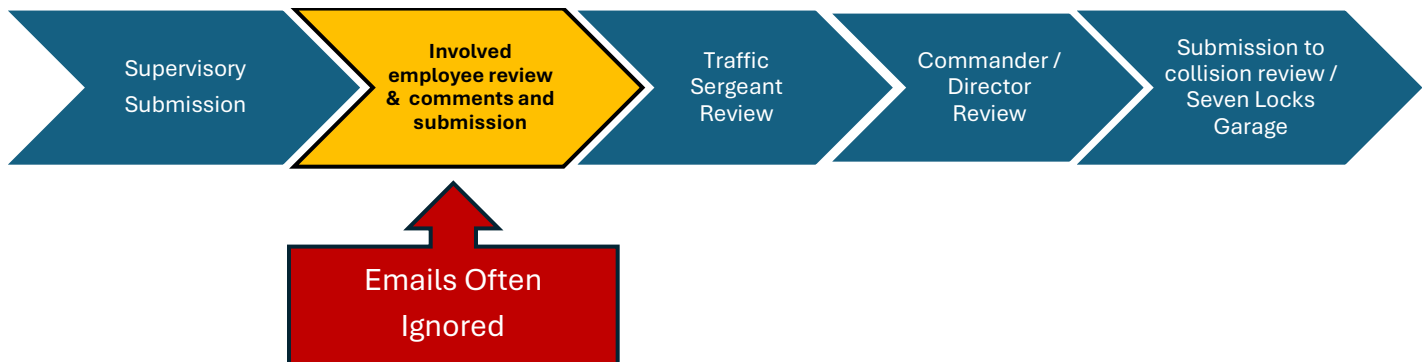

Supervisor's Comments:	

The supervisor will determine whether the employee was at fault and determine if the collision was preventable by the employee (not another involved party)

After the MCP 611 is complete, the submission of the report by the supervisor will automatically trigger the following flow:



A reminder email to complete the report will be sent daily to the involved employee. If the employee is unable to acknowledge the report due to injury or other reasons, contact pol.hqtrafficcmdr@montgomerycountymd.gov, who will acknowledge the report on their behalf.

The report can only be rejected by the Traffic Sergeants or Command Staff. If this occurs, the report will be rejected to the submitting supervisor **with comments**. After correction, the flow will begin again.

Guidelines/Tips

1. The site is best viewed utilizing Edge. It can only be viewed while connected to the network or VPN. If using an MDT, make sure you are connected to \\mcgov
2. Previously approved reports are always available to review by clicking on "my reports" or by the search feature.
3. To request deletion or reopening of an approved report or to report an issue, submit a help desk ticket:
