#### RecAssist 2020

The current RecAssist fund is available January 1, 2020 through December 31, 2020. Applications accepted from December 16, 2019 through November 30, 2020.

A minimum 20% co-payment per class or program, per participant, is required at the time of registration. Your co-payment will be higher if you don't have enough RecAssist funds remaining on your account to cover 80% of the activity/program fees.

Use of the RecAssist fund is available on a first come, first served based. You may use the amount on your account only until the RecAssist Fund is used up.

Once the RecAssist fund is used up you must pay full price for all registrations, even if you have not used the entire RecAssist amount on your account.

The total amount that a family qualifies for will be placed on the family account and may only be used by eliqible family members.

## Where to Submit Your Application and Copies of Documentation (No Originals)

Your application and documentation can be submitted online. You may also mail-in, fax-in, or walk-in your completed application and required documentation.

### Who Is Eligible For RecAssist?

Montgomery County residents who provide documentation that they are current recipients of the following benefits:

TEMPORARY CASH ASSISTANCE
HOUSING ASSISTANCE FROM A SHELTER
SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM
MONTGOMERY COUNTY, MD RENTAL ASSISTANCE PROGRAM
SUPPLEMENTAL SOCIAL SECURITY INCOME
MARYLAND MEDICAID
CARE FOR KIDS
MARYLAND ENERGY ASSISTANCE
WIC

You may only use one type of assistance to qualify for RecAssist funds. All eligible family members will receive \$200 in RecAssist funds.

### **Details Of The RecAssist Program**

Allow five business days from receipt for your application to be processed. The total shown is for your eligible family members to use between January 1, 2020 to December 31, 2020. You may qualify only once per year.

RecAssist may only be used for Montgomery County Recreation classes and programs such as yoga, summer camps, swim lessons, swim passes and swim punch pass. (Note: you may purchase one swim punch pass per eligible family member per year with your RecAssist funds.)

RecAssist may not be used for sports team league fees; facility rentals; recreation gift cards; daily pool admissions; supplemental fees including security deposits, withdrawal fees, materials fees, late pick-up fees, or to purchase aquatic merchandise; a previous balance on your account and/or an adjustment of previous registrations.

RecAsisst funds may not be used for programs that cost less than \$25.

Unused RecAssist funds will be removed from your account on December 31, 2020 or when the RecAssist fund is depleted.

All Montogomery County Recreation withdrawal, transfer and refund guidelines apply.
