Building a more equitable and inclusive Montgomery County by promoting safe neighborhoods and communities that are better for all County residents.


- · Identify and address implicit bias and institutional racism in all aspects of the public safety system.

To Reimagine Public Safety in Montgomery County.

- Develop a set of recommendations that reimagines the Montgomery County Police Department and all public safety programs by January 18, 2021.

2. COLLECT, RESEARCH AND ANALYZE DATA AND INFORMATION

- . Analyze 911 calls dispatch data and Police records management system to determine the types of calls Police responds to.
- Analyze 311 calls to determine community needs.
- Evaluate Police Department budget and structure to determine how resources are allocated.

3. REVIEW POLICIES AND PROCEDURES

- Hire a consultant to conduct an independent audit of the Police Department
- Assess the impact of enforcement operations (policing) practices)
- Assess MCPD hiring, training, promotion, and evaluation
- Provide recommendations for reforms

4. REIMAGINE COUNTY RESPONSE TO **COMMUNITY NEEDS**

For health and social services where Police is filling the void.

- Develop robust crisis response mechanism
- Create a sustained support and integrated case management approach
- Partner with other county departments, non-profit organizations and others to find alternatives

5. INITIATE POLICE DEPARTMENT REORGANIZATION

- New assistant civilian Police Chief
- Telephone reporting unit
- School resource officers
- District community action teams
- Traffic unit
- Professional accountability division
