- 1. 7:05 Welcome and self-introductions: Vice Chair Michelle Desiderio Foster called meeting to order.
- 2. Acceptance of previous meeting summary: November minutes were approved.
- 3. Fire Safety for the Holidays: Charles Bailey, MCFRS Division Chief of Human Resources, reported on a variety of winter fire hazards including fireplace ashes, space heaters and Christmas trees. MCFRS provides scheduled home safety inspections on weekends. Chief Bailey, noting the surge in light weight, wood residential construction in the area, would like to add resources or move them to the downtown area.
- 4. Neighborhood/Community Spotlight: Laura Barclay reported on the Old Takoma Business Association, a cross jurisdictional, 501C3 organization that promotes street-front businesses near the Takoma Park Metro station. They organize a variety of events through the year. Their biggest challenge is competing with better-funded districts like downtown Silver Spring.
- 5. Education Conversation focusing on MCPS boundary study, opportunity gap and educational inequities was moderated by John Seelke. Panelists included: Brian Kramer, a Northwood graduate and current American University student; Chris Wilhelm, ESOL teacher at Northwood; and Lynne Harris, teacher at Edison's technology health program and MCCPTA President. The board engaged in a broad ranging discussion of education topics. Ms. Harris confirmed that MCPS is 'a highly diverse school system, but not a system of diverse schools'. The speakers agreed the current boundary study came about because students pressed the school board. The overall feeling was that a comprehensive, objective, expert-driven study can only produce benefits or at least the option to take advantage of potential benefits. It was commented that other school systems review boundary issues on a regular basis to assess resource allocation. The report is due in May 2020.
