### 2. Minutes from previous meeting

a. November minutes were approved

## 3. Public Safety Report (Lieutenant Reed)

- a. Commander McBain sends his apologies as he is attending another meeting
- b. Commended team members on rapid arrest (< 12 hrs) in Dash In homicide
- c. Indicated that numerous recent arrests have brought about a decrease in thefts from autos (parts and contents) and outdoor sheds.
- d. Talked about strong partnership with DC and PG police working along the borders.
- e. In DTSS, high visibility enforcement efforts are paying off, allowing for deployment of "purposeful policing."
- f. High visibility enforcement is also bringing about a decrease in carjackings.
- g. County gun recovery program doing well. In 2022, 1100 guns recovered countywide, 170+ in 3<sup>rd</sup> district.
- h. DUI task force (10 officers plus support from Sheriff's office and Rockville and Gaithersburg) has made over 1200 traffic stops resulting in 140+ arrests.
- i. Jay mentioned the regular conflict with the MoCo Civic Federation meeting on the 2<sup>nd</sup> Monday and likely why Commander McBain has a conflict.
- j. Michelle expressed appreciation for the public safety reports.
- k. John posed a question about resolving the info from the public safety reports against that which reads on the local listservs. Lt Reed suggested caution, being observant, but not putting yourself in harm's way.
- Jonathan asked if thefts of catalytic convertors were up or down in our neighborhood. Lt. Reed replied that they are down. Kate Stewart spoke of an auto shop in Takoma Park that will engrave your name on the catalytic convertor n your car.

#### 4. Topic One: New County Councilmember from District 5 (Councilmember Kristin Mink)

- a. Greeting to SSCAB
- b. Grew up in Woodmoor, Blair graduate, taught in MCPS, mother of two.
- c. Went into community advocacy
- d. Member of the Education and Culture Committee, interested in better retention of teachers, equitable distribution of resources
- e. Member of Public Safety Committee, looking at policing, mental health resources
- f. Also concerned with transportation issues, the US 29 BRT runs through her district.

- g. Made reference to Thrive 2050 and concerns with how it is implemented.
- h. Katherine asked about CM Mink's plans for Vision Zero and rent stabilization....CM Mink's responses for VZ included more support from both the state and the county as well as setting goals to ensure accountability. For rent stabilization, she talked about multiple areas of effort and increasing housing stocks, noted that big rent increases are happening now.
- 5. Topic Two: New County Councilmember from District 4 (Councilmember Kate Stewart)
  - a. Greeting to SSCAB
  - b. Introduction of staff members
  - c. Chair of Government Operations Committee
  - d. Member of Transportation and Environment (T&E) Committee, looking at pedestrian and bicyclist safety
  - e. Also concerned with housing supply and housing equity issues, from TP which has rent stabilization now,
  - f. John asked about open campus schools and problem with nearby merchants and MCPS claiming not their issue....CM Mink responded about experience as a MBHS student and a Starbucks employee...CM Stewart stressed the need for communications between the parties....
  - g. Ken asked about affordable housing strategies and if there might be some common ground with the CE...CM Stewart responded about looking at rent stabilization and dealing with potential Purple Line displacement....also mentioned the value of fixed mortgage payments versus rent...improved ownership opportunities through down payment assistance....spoke of tenant right to purchase and an example in TP....CM Mink mentioned the Hillandale Gateway Project...CM Stewart spoke of the Housing Production Fund, help to fund MHP, and low income housing tax credits.
  - h. Vanessa asked about getting resources to lower income residents....CM Mink responded suggesting better coordination of government and NGOs who are already embedded with community and have the needed cultural competence.
  - i. Several people asked in the chat about beltway widening, both CM's expressed opposition to beltway widening.
