Daniel Jones – Mr. Jones focuses on community engagement in order to meet the goal of the 2020 Census which is to count everyone once, only once and in the right place. "The Census Bureau will continue to improve its use of mobile technology, geospatial innovations, and internet self-response. It is mandated by Article I, Section 2 of the Constitution and takes place every 10 years. The data collected by the decennial census determine the number of seats each state has in the U.S. House of Representatives (a process called apportionment) and is also used to distribute billions in federal funds to local communities. The next Census in 2020 will require counting an increasingly diverse and growing population of around 330 million people in more than 140 million housing units. The decennial census is the largest mobilization and operation conducted in the United States and requires years of research, planning and development of methods and infrastructure to ensure an accurate and complete count."

Seth Adams – Mr. Adams is the Director of Montgomery County Public Schools' Division of Construction which efficiently plans and manages design and construction processes to provide quality learning environments in a timely manner.
