	• Christopher O'Brien moved and Jay Guan seconded motion to adopt, minutes were adopted				
	without objection				
7:05 p.m.	Topic: Police Commanders and Public Safety				
1	• Cmdr. Dillman (District 1) –				
	• Protecting the faith community in light of the Middle East conflict and the spike of				
	hate crimes locally.				
	 Stopped deploying officers in Rockville, except in case of emergency when 				
	municipal officers cannot make it in time.				
	• 154 officers short, projected to be down 190 if the trend continues (which is larger				
	than the number of officers within the 3 rd District)				
	 MCPD has had to be less exclusive in selection and hiring because of the staffing crisis nationwide → would-be officers know they can go anywhere 				
	 Paul Klee asks what is causing the shortage? 				
	 Loss of confidence in law enforcement nationwide. 				
	• Wayne Jacas asks about what accountability is present for bad officers?				
	Cmdr. Dillman states that internal affairs has always led to officers being				
	terminated when they need to be.				
	• Cmdr. Pallas (District 5) –				
	• Travelling the country and speaking with other departments, where not everyone has				
	the same staffing shortage that we have here.				
	 Body-worn cameras are good for accountability. 				
	 Don't have the capacity for parking or traffic enforcement. Kreis Walalahan missid assessments about an all similar maximum based 				
	 Kraig Walsleben raised concerns about an all-civilian review board Wayne Jacas states that accountability is necessary as well and that the community 				
	does support and respect the officers.				
	 Lt. Estrada (District 6) – 				
	• Transitioned over to full control of municipal officers in Gaithersburg, with support				
	from MCPD as needed.				
	• There are several developmental programs in Seneca Valley HS and Thomas Edison				
	HS				
	• Mentorship program (Explorer Program) helped Cmdr. Stancliff and Lt. Estrada in				
	their careers.				
	• Revonne Johnson spoke out in favor of the community engagement and mentorship programs				
	for restoring relationships with the community and expressed concern with the lower				

recruitment resulting in fewer quality options during hiring.

- Mary Hoel asks what would the commanders do to address the staffing shortage?
 - Cmdr. Dillman says altering the political discourse and higher compensation relative to neighboring jurisdictions to reflect the higher cost of living.
- Steve Robinson asked about what is being done in terms of engagement with the community and how that has been impacted by low staffing.
 - The loss of SROs is a concern.
 - There has been less ability to engage proactively in the community because of the lack of officers and how spread thin they are.
- Chris O'Brien states that local enforcement of traffic violations may make sense and that there may be room for automation to address some of the shortage in traffic enforcement.
 - Cmdr. Dillman states that there is a lot of red tape
 - Legislative proposal to permit speeding cameras in places where the speed limit is 45 mph or less (right now it is 35 or less)
- Wayne Jacas asked if there are other things, like ankle monitors, that can be used to keep youth out of trouble if they cannot be jailed.
 - Cmdr. Dillman says that there is little they can do to intervene, which is demoralizing.
- Captain Cokinos discussed the drone program, which is a pilot program just in Silver Spring to automate first response to some crimes and allow for better de-escalation.
 - The drones also permit more efficient use of officers as they can determine whether an officer is even necessary.
 - Pilot runs until June 30, 2024.

 - Andrew Saundry asked how this was distinct from the Baltimore surveillance drone program
 - Capt. Cokinos states that this is reactive, instead of proactive, and that it is not broad surveillance of any areas outside the specific scope immediately surrounding a call zone.
