- Cmdr. Dillman Recent increase in anti-Semitic bomb threats (part of national trend)
- Cmdr. Pallas Positive bystander intervention
 - Stave Robinson asked a question about the "smash and grab" at a gun store in
 Damascus → No arrests at this time, but law enforcement has identified suspects
- Lt. Cox Good news about the Cider Mill community, where there were under 100 calls for service in December for the first time in months

7:15 p.m. Update from Councilmember Dawn Luedtke

- Preserving the Damascus HS automotive program is a priority
- Technical amendments to the juvenile justice system in the MGA are expected this legislative session
- Working to improve hiring bonuses and retirement benefits to increase hiring of officers
- Concerns that restrictions on prior cannabis use will prevent many young people from becoming law enforcement
- Drone pilot program potentially coming to Gaithersburg and Germantown as they have found a new site to host it. Co-sponsored w/ Councilmember Marilyn Balcombe
- Airpark liaison committee has been revived
- Two bills to highlight this year:
 - Crisis intervention teams
 - Creating a voluntary 911 call registry
- Wants to engage more people via "Local Government 101" so folks can testify on legislation that they care about in the Maryland General Assembly
- Paul Klee asked about a ZTA that Councilmember Natali Fani-Gonzalez proposed
 - Councilmember Luedtke explains that the state approved a definition of agrotourism to include camping and "incidental outdoor stays" and Councilmember Fani-Gonzalez's proposal would extend that to Montgomery County.
 Councilmember Luedtke doesn't support this ZTA in its current form because of uncertainty over the definition of "incidental outdoor stays" and a desire to protect

the ag reserve. She is in discussion with the Montgomery Countryside Alliance and other organizations in the Ag Reserve.

7:35 p.m. Damascus High School Auto program: MCPS Board of Education Member Grace Rivera-Oven and others will talk about the auto program at Damascus High School.

- Board of Education Member Grace Rivera-Oven was an automotive student in High School opposes efforts to eliminate the program at Damascus. She is currently working to protect it.
- Mr. Ortiz:
 - MCPS was going to cancel it for lack of a facility during the rebuild, even if the school system were to add a new one upon completion
 - There has been discussion of sending students to SVHS, but he argues that is not workable
 - o Meeting this Wednesday at 6pm in Damascus HS to discuss the issue
- Heard from 6 Students of the program from the last 3 decades and the President of the Auto Trades Foundation
 - Inspired a passion for manufacturing work
 - o Moved students into good jobs (6 figure salaries right out of High School)
 - Desperate need for mechanics in local repair shops
 - o Inspired numerous lifelong career
 - Students will not make the drive to Seneca Valley HS
 - o 4 programs in Montgomery County, overseen by the Auto Trades Foundation, which certifies them → President states that there is a need to expand these programs, not cut them back

Wayne Jacas moved and Christel Bivens seconded that we will write a letter for consideration at the next Full Board Meeting.
