Topic: Bill 16-23, Landlord-Tenant Relations – Rent Stabilization (The HOME Act)" guest speakers:

## Overview:

- Housing Opportunity, Mobility, and Equity (HOME) Act, introduced by Council members
   Will Jawando (D) and Kristin Mink
- The bill caps annual rent increases at 3% or to match the Voluntary Rent Guidelines, an annual figure set by the county government whichever is lower.
- Exempt new construction for 10 years, allow increase for capital improvements
- We must do everything we can to keep those who live in our county housed. Moving is
  disruptive for children and workers, dangerous for the elderly and disabled, and costly
  for anyone. And high rent increases disproportionately affect the most precarious
  populations, including low-wealth households and people of color. Rent stabilization is
  necessary to bring stability and predictability.
- Rent stability and predictability are vital for renters and beneficial to commercial lenders and developers.

• Renters alliance Board - we are only board Nonprofit for tenant outreach we partner with

county and other outreach services to help tenants understand eviction, rent increases and from policy perspective feel that rent stabilization should be on the table to help with the affordable housing crisis

- Crisis? Why? Renters almost 40% of county.....upcounty many tenants will be positively impacted by this bill
- Some landlords increase can be reasonable (2%-3%) but there are many outliers who rent gauge with increase in double digit
- We need to help and assist for those who can no longer afford becasue of the gauging and forcing migration which destabilizes the communities;
- Community Stability and you have to balance landlord rights with tenant rights
