High Injury Network Roadway Modifications	Complete design and begin construction for improvements on two HINs.	On-Going & On- Schedule	This year, MCDOT will focus on Crabbs Branch Way and Sam Eig HINs for roadway modifications. Studies for both corridors have been completed and moving into design work. Some signal work resulting from the Crabbs Branch study has been implemented.
High Injury Network Signal Modifications	Complete design and begin implementation of signal modifications at County controlled signals in the Shady Grove HIN from Frederick Road to I-270 in 2020.	Delayed Due to COVID-19	This year, MCDOT will focus on the Shady Grove HINs for signal modifications. Work underway includes updated data analysis for the Shady Grove corridor from I-270 to Mill Run. Field observations were suspended due to the public health emergency and have delayed the study for this project. Field work and observations resumed in October.
Implement Pedestrian Road Safety Audit (PRSA) Recommendations	Improve pedestrian crossings along Bel Pre Road; install signal at Wisteria Drive and Crystal Rock Drive and implement lane narrowing along Middlebrook Road.	On-Going & On- Schedule	This year, MCDOT will focus on the Bel Pre Rd and Middlebrook Rd HINs for implementing road safety audit recommendations.  Construction of the Middlebrook Rd interim road diet and bike lanes started in July and will finish this year. The signal construction at Wisteria and Crystal Rock is on schedule to be completed this year.  Work on Bel Pre Rd is continuing since data collection and field observations were completed prior to the public health emergency. Existing beacons will be upgraded to Pedestrian Hybrid (HAWK) beacons.
